A Bylaw to Authorize the Dedication of Land as Regional Park

## WHEREAS:

A. the Greater Vancouver Regional District has acquired land legally described in attached Schedule 1 (the "Land") for regional park purposes;

B. Section 30 of the *Community Charter*, applicable to regional districts pursuant to section 302 of the *Local Government Act*, authorizes a regional district to dedicate land as park by way of a bylaw.

NOW, THEREFORE the Board of the Greater Vancouver Regional District in open meeting assembled enacts as follows:

This bylaw shall be cited as "Greater Vancouver Regional District Dedication of Land as Regional Park Bylaw No. 1076, 2008."

## 1.0 Dedication

The Land is dedicated as regional park.
