

PUBLIC NOTICE

LICENCE AMENDMENT APPLICATION FOR AN EXISTING COMPOSTING FACILITY

TAKE NOTICE THAT Anaconda Systems Limited located at 8601 Main Street, Vancouver, BC, V5X 3M3 has applied to the Greater Vancouver Sewerage and Drainage District (“GVS&DD”) pursuant to the *Greater Vancouver Sewerage and Drainage District Municipal Solid Waste and Recyclable Material Regulatory Bylaw No. 181, as amended* (“the Bylaw”), to amend Licence C021.

Overview

The Composting Facility licence amendment application requests authorization to:

1. Update Section 4.5 Facility Works
2. Add wood chips as an Acceptable Material
3. Increase the quantity of Compostable Material that would be stored at the Facility at any one time from 100 metric tonnes to 6,661 metric tonnes
4. Adding the quantity of Finished Compost that would be stored at the Facility at any one time at 923 metric tonnes
5. Update Section 5.6 Material Handling and Storage
6. Update Section 5.7 Operating Practices
7. To expand the Receiving Hours from Sunday to Saturday 7:00 a.m. to 5:00 p.m. to 7:00 a.m. to 7:00 p.m.

The legal description of the land or premises where the Facility is located is PID: 009-165-088, Lot B. except North feet now road Block 13, Plan VAP5270, District Lot 322, Group 1, New Westminster Land District.

Materials Summary

The licence amendment application proposes the following changes to the maximum quantity of materials that would be stored at the Facility at any one time:

The licence amendment application proposes the following changes to the capacity of the Facility:

This notice is published pursuant to the Bylaw. The licence amendment application is at a preliminary stage where it will be reviewed by the municipality in which the Facility is located.

A person who may be adversely affected by the issuance of the requested licence amendment described in this notice may notify the GVS&DD Solid Waste Manager in writing stating how that person would be affected. The public notification period is no less than 30 days after the publication date of this notice. Aspects of the proposal may change as the application proceeds through the municipal review and public comment processes.

Information collected during the comment period and the time following until a decision on the licence amendment application has been made is done so by Metro Vancouver in accordance to *s.26(c) of the Freedom of Information and Protection of Privacy Act*. The information collected will be used for the purpose of making a decision on the licence amendment application and will be forwarded to the licence applicant for response to the Solid Waste Manager. By submitting a public comment, you consent to such disclosure. Also, your submission may be made available to the public as part of the public record, subject to the provisions of the *Freedom of Information and Protection of Privacy Act*.
