I. OTHER BUSINESS

1. European Experience on Solid Waste Management

Director Brodie updated the Board on a July 22, 2014 Zero Waste Committee special meeting where presentations on European waste management were given by Herman Huisman, Senior Advisor International Cooperation, The Netherlands Ministry of Infrastructure and the Environment, and Phil Conran and Vicki Cooper, Directors of 360 Environmental, a water management regulatory consulting firm in England.

Director Brodie further highlighted key learnings from the presentations including:

- European movement towards circular economies
- Successful implementation of European Union directives to reduce waste to landfill in many European countries
- European efforts to reduce waste focused on source separation
- increasing collection of source separated organics in the UK and the Netherlands with significant development of new anaerobic digestion facilities
- European countries with high use of WTE having high recycling rates
- Mixed waste materials recovery facilities being unsuccessful due to low quality product
- The UK exporting residual garbage to WTE energy facilities in the Netherlands
- Collaborative efforts by environmental groups, government and industry on regulatory changes to environmental standards for WTE facilities in the Netherlands
- There no longer being significant environmental concerns with WTE in the Netherlands, and in England, remaining concerns being largely related to impacts from truck traffic
- Annual WTE dioxins in the Netherlands being less than those emitted from fireworks demonstrations
