

Transfer Application Form for Waste Discharge Permits



In order to request transfer of a Waste Discharge Permit resulting from a **change in company name or ownership**, please complete this form. Company name changes require an amendment to any Waste Discharge Permit. An amendment to the Waste Discharge Permit is **not required for ownership changes which have not resulted in a registered company name change**. However, a Transfer Application form is required in order to update Metro Vancouver records.

To apply for other amendments to a Waste Discharge Permit, application must be made in writing and submitted for processing. **If you are applying for an amendment to a Waste Discharge Permit in addition to a name/ownership change, please attach the Transfer Application form to the amendment application.**

General Instructions for Completing Transfer Application Form

- Complete Section A General Information for all requests.
- Complete Section B for registered company name changes only.
- Complete Section C for ownership changes only.
- Complete Sections B and C for changes to both company name and ownership.
- Complete Section D: To be signed and dated by an executive of the company.
- **Copies of legal documentation of the name change and/or ownership change must be provided with the form.** This legal documentation should include a corporate registry search of the applicant.

Corporate registry searches can be obtained for a nominal fee from:

- By using the services of companies listed in the yellow pages under "Title Service".

The fee for a change of Company Name is \$250.00 and payment options are:

- Electronic Fund Transfer (EFT) or Wire Transfer*
- Online Bill Payment*
- Credit Card – Visa or MasterCard only*
