2026 Discharge Fees for Trucked Liquid Waste

On October 31, 2025, the Greater Vancouver Sewerage and Drainage District (GVS&DD) Board approved fee increases for trucked liquid waste discharges at Metro Vancouver facilities. The fees will go into effect on **January 1, 2026**.

The 2026 fees will allow Metro Vancouver to recover more costs associated with its trucked liquid waste program for domestic and non-domestic waste discharges at its trucked liquid waste facilities, including the Iona Island, Annacis Island, and Northwest Langley wastewater treatment plants.

How Trucked Liquid Waste Fees are Calculated

Fees for discharging trucked liquid waste are based on volume, with different rates for domestic and non-domestic waste. Waste generated outside of Metro Vancouver (out-of-region waste) is subject to higher fees to recover the additional costs associated with managing these unplanned discharge requests.

2026 Trucked Liquid Waste Discharge Fees

Trucked Liquid Waste Type	2026 discharge fees (\$/m3)	Forecasted 2027 discharge fees (\$/m3)
In region ¹ domestic waste	\$72	\$84
In region ¹ non-domestic waste	\$117	\$133
Out-of-region ² domestic waste	\$90	\$108
Out-of-region ² non-domestic waste	\$144	\$173

¹ In-region waste refers to trucked liquid waste that is generated within the [Metro Vancouver region](#).

² Out-of-region waste refers to trucked liquid waste that is generated outside of the [Metro Vancouver region](#).

Forecasted fees for 2027 are subject to change. Actual fees will be calculated and presented annually based on that year's budget. Moving forward, the GVS&DD Board will determine a new trucked liquid waste fee schedule annually to ensure the program's full costs are recovered each year.

Northwest Langley Facility Only Accepts Domestic Waste from Township of Langley

Metro Vancouver has added language to the [Trucked Liquid Waste Bylaw](#) reinforcing existing rules on what wastes can be discharged at the Northwest Langley Wastewater Treatment Plant's trucked liquid waste facility. As a reminder to haulers, this facility only accepts holding tank waste generated within the Township of Langley. All other waste types, including portable toilets, must be discharged at the Iona Island and Annacis Island wastewater treatment plants.
