

Ambient Air Quality Report for Metro Vancouver Waste-to-Energy Facility

Monthly Summary Report - January 2025

Prepared March 14, 2025

Metro Vancouver operates a network of ambient air quality monitoring stations in Metro Vancouver and the Fraser Valley and one of these monitoring stations is Burnaby South (T018) which is located near to Metro Vancouver's Waste-to-Energy Facility. In 2025, additional hydrogen chloride (HCl) monitoring was installed at Tsawwassen (T039) to better understand regional HCl ambient concentrations.

Data in this summary report is considered preliminary. While some preliminary quality assurance and quality control has been applied to the data, it is subject to change, without notice, pending the completion of additional quality assurance, quality control and verification procedures by Metro Vancouver at a future time.

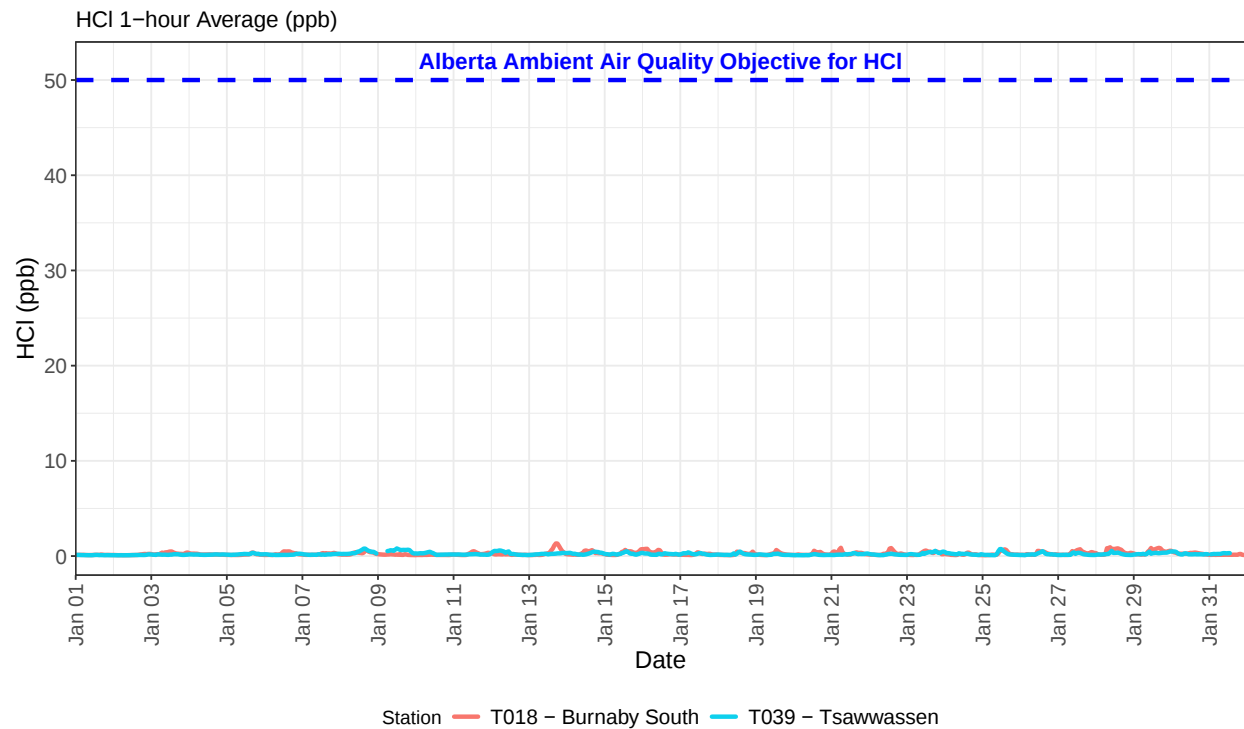

HCl (hydrogen chloride) Monthly Summary

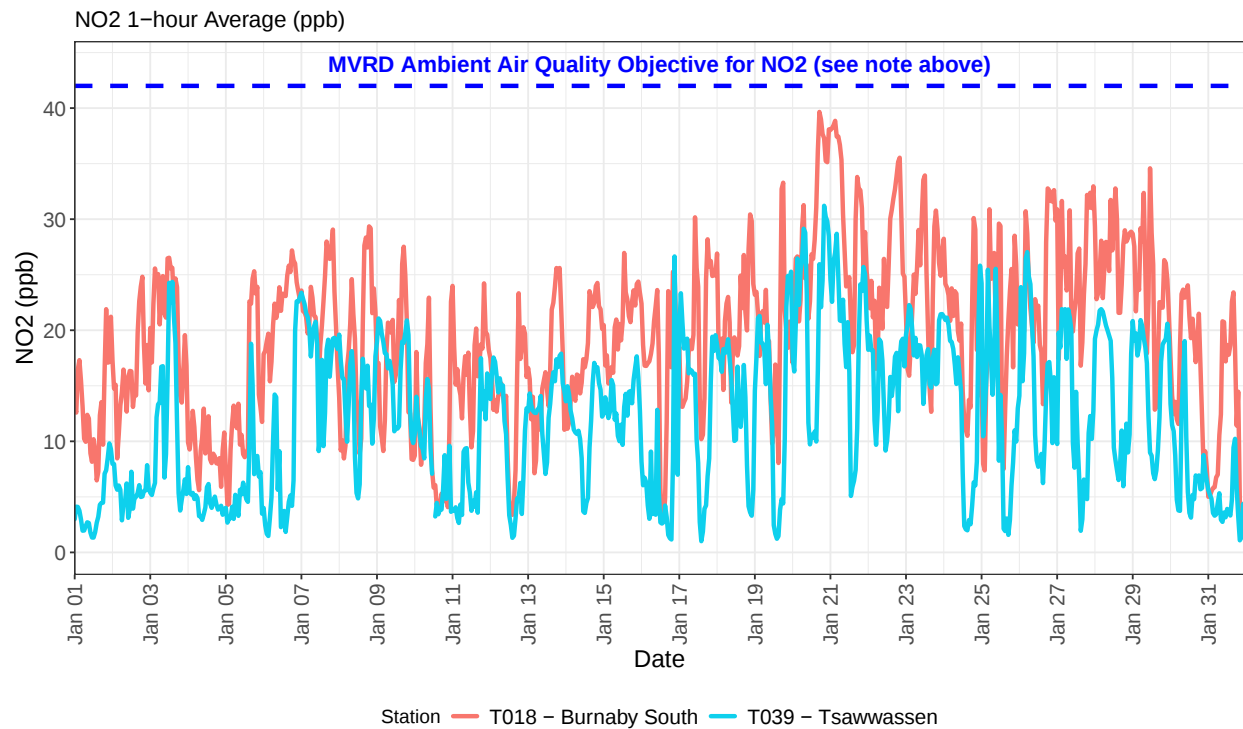

NO2 (nitrogen dioxide) Monthly Summary

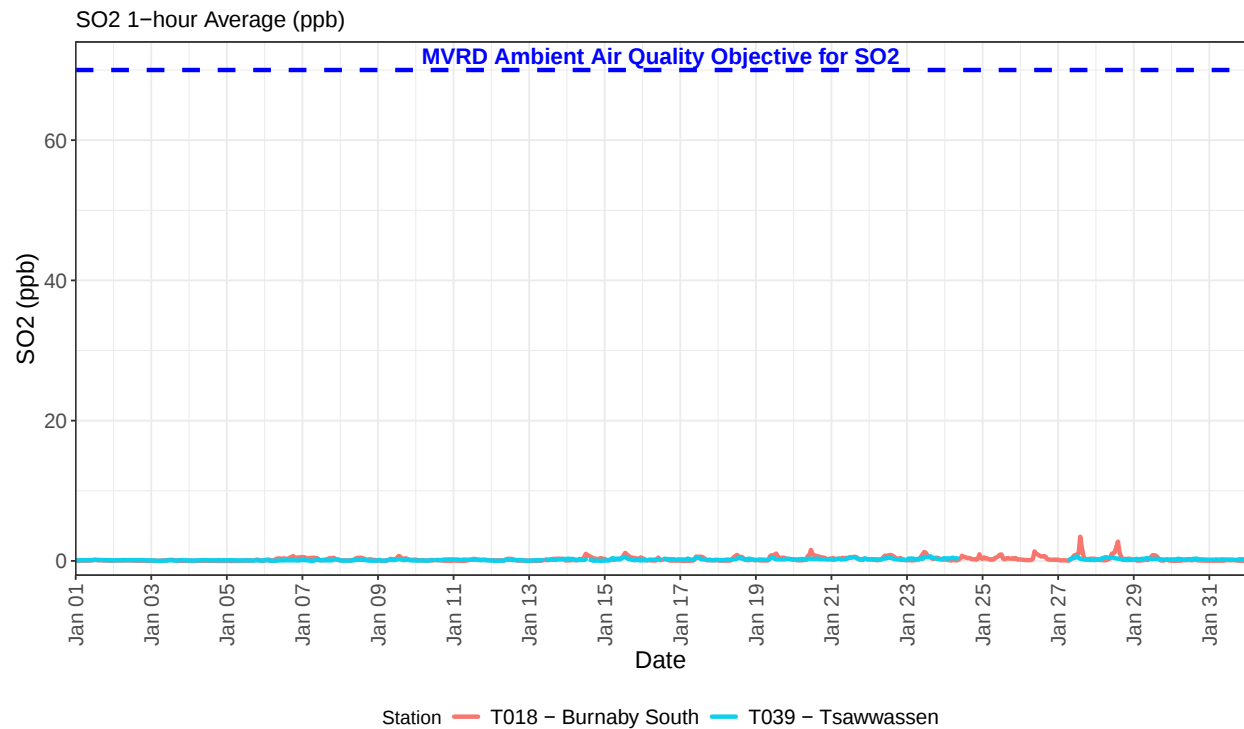
Metro Vancouver's ambient air quality objective for 1-hour NO₂ is based on the analysis of three consecutive years of data, the annual 98th percentile of the daily maximum 1-hour concentration is averaged over three consecutive years. The dashed blue line in the figure below shows the numerical value of Metro Vancouver's 1-hour NO₂ ambient air quality objective (42 ppb). If the preliminary NO₂ data shown in this report has a concentration above the numerical value, it does not necessarily indicate an exceedance of the Metro Vancouver objective. Achievement of the objective is determined at the end of each calendar year.

Metro Vancouver's ambient air quality objective for 1-hour SO₂ is a never to exceed objective. The dashed blue line in the figure below shows the numerical value of the SO₂ objective, 70 ppb.
