




WHAT IS INCLUDED

Facility or Material Type	How it's incorporated
Waste-to-Energy Facility	Counted as disposal except for metals recovered for recycling
EPR Materials	Residuals counted as disposed where reported by stewards
Composting Facilities	Residuals counted as disposed for facilities within Metro Vancouver
Material Recovery Facilities	Residuals counted as disposed, outbound materials sent for processing counted as recycling, including material used as fuel substitutes
Processing Facilities	Residuals counted as disposed for facilities within Metro Vancouver

WHAT IS NOT INCLUDED

- Agricultural Waste
- Industrial Waste
- Forestry Waste
- Water and Wastewater Treatment Plant Residuals
- Material Managed On-Site (e.g. Backyard composting)
- Excavation Soils
- Landfill Cover Material
- Scrap Metal from yards or automotive recycling


2023 Recycling Rate Highlights

- Commercial waste generation continued to increase while residential waste generation has tapered off



From all Sectors




RECYCLING RATE TREND BY SECTOR

2023 Recycling Highlights

- Increases in wood, gypsum and plastic
 - Most notable from commercial non-EPR materials
 - Reported recycled concrete and asphalt tonnage from facilities increased
 - 2021 Unlicensed Facilities

Notice of Bylaw Violation Bylaw - Tipping Fee Bylaw Provisions

NOTICES OF BYLAW VIOLATION

- Notices of Bylaw Violations are an administrative compliance promotion tool available to local governments:
 - Penalty amounts up to \$500 per offence
 - Discounts for early payment and surcharges for late payment
 - Independent dispute adjudication process

METRO VANCOUVER NOTICE OF BYLAW VIOLATION HISTORY

- Notice of Bylaw Violation bylaws in place for MVRD and member jurisdictions
- April 2023: GVS&DD and GVWD were granted authority to develop Notice of Bylaw Violation bylaws
- May 2024: Notice of Bylaw Violations in place for liquid waste bylaws
- July 2024: Notice of Bylaw Violations in place for GVS&DD Bylaw 181 (solid waste facility licensing bylaw)

TIPPING FEE BYLAW NOTICE OF BYLAW VIOLATION PROVISIONS
