#### **MEETING MINUTES**

Co-Chair Craig Hodge called the meeting to order at 2:01 p.m. and welcomed attendees to the Solid Waste Industry and Recycling Advisory Committee meeting. Participants were reminded to use the Zoom "raise hand" function to provide questions or comments or for any voting that might be required, and to ensure their names were correctly identified in the Participant list.

#### 1. NEW CO-CHAIR INTRODUCTION

Co-Chair Hodge welcomed new Co-Chair Lori Bryan, Waste Management Association of BC. Co-Chair Bryan offered appreciation for being voted in as the Co-Chair and provided background on being part of the Industry Advisory Committee and the history of its conception. It was noted that the active participation from Committee members will help guide the Industry Advisory Committee to serve its intended purpose, develop real solutions, and achieve success.

Co-Chair Hodge commented on preliminary discussions held with Co-Chair Bryan on next steps for the Industry Advisory Committee and remarked on looking forward to working together. Appreciation was extended to Metro Vancouver staff who helped facilitate the recent national Zero Waste Conference.

#### 3. MINUTES

#### 3.1 October 3, 2023 Meeting Minutes

Co-Chair Hodge called for any additions or changes to the meeting Minutes of October 3, 2023.

During ensuing discussion, comments were offered related to:

- Concern that Committee members may not have seen a post, which was uploaded to the Industry Advisory Committee website under the meetings tab for 10/03/2023, titled "GVS&DD Act Excerpt", which explains the authority for the generator levy in Section 7B of the Greater Vancouver Sewerage and Drainage District (GVS&DD) Act
- Disagreement that Section 7B of the *GVS&DD Act* provides Metro Vancouver the authority to implement the generator levy
- Suggestion that the meeting minutes of October 3, 2023, include:
  - The explanation provided by Paul Henderson, General Manager, Solid Waste Services related to the GVS&DD Act (1995), offered during the October 3, 2023, meeting
  - The GVS&DD excerpt (posted to the Industry Advisory Committee website)
- Clarification that providing the GVS&DD excerpt to Committee members (via the post on the Industry Advisory Committee website) was a follow-up of the Action item identified at the October 3, 2023, meeting.

#### 4. REPORTS

### 4.1 Disposal Ban Program Review

Klaryssa Lawrie, Associate, Dillon Consulting, provided an introduction, referred to a presentation titled "Disposal Ban Program Review", and highlighted the purpose, which was to review Metro Vancouver's Disposal Ban Program and determine efficiencies of the inspection program and application of surcharges.

Lynne Vidler, Lead Senior Engineer, Metro Vancouver, referred to a presentation titled "Metro Vancouver Disposal Ban Program Review" and highlighted the recommendations from the Consultant and the responding actions Metro Vancouver is taking or is planning to take.

During discussion and in response to questions, comments were offered regarding:

- Confirmation that the visual inspection process provides a good indication of what is in the loads
- Limitations with only inspecting the exterior of a load, and hope to continue the disposal ban program and initiate a pilot to look at other tools to demonstrate the maximizing of recycling
- The balance between adding additional inspectors with the cost incurred; the current level of inspectors ensures that haulers are not intentionally avoiding inspectors
- Surcharges for remediation; the tipping fee bylaw identifies different materials (e.g. hazardous materials have a larger surcharge if remediation is required
- Suggestion that the report is only validating something that is already known, and doubt in the value in bringing in a third-party consultant.

**ACTION:** Metro Vancouver staff to remove pictures of Waste Collections of Canada trucks, depicted in the Disposal Ban Program Review Presentation.

#### 5. INDUSTRY ADVISORY COMMITTEE DRAFT 2024 WORK PLAN DEVELOPMENT

Paul Henderson, General Manager, Solid Waste Services, referred to the Industry Advisory Committee 2023 Work Plan provided with the agenda package and reported on items completed in 2023, items currently in progress, and items proposed to be carried into the 2024 work plan.

Co-Chair Bryan continued the discussion on possible items to be carried forward to the 2024 Industry Advisory Committee Work Plan, including:

- Organics Capacity
- C&D Capacity
- Recycled Product Markets
- Solid Waste Management Plan (SWMP) Update Idea Generation
- Policy and Competition
- Reuse and Share Ideas.

During discussion on additional topics Industry Advisory Committee Members might want to focus on in 2024, the following topics were raised:

- The future of the Vancouver Landfill and long term planning
- Disposal contracts and how they fit in the disposal matrix within Metro Vancouver
- Recycling statistics, computation, and presentation
- Explanation of the past and future anticipated Solid Waste expenditures budget
- Residual Items Review, which is currently under a draft scope for consultation and will be brought to Committee members for discussion and updates as the study moves forward
- Recycled products markets
- Innovation and options to divert materials out of the region's waste streams, e.g. organics, and helping support other organizations' organics systems
- Future capacity and lifespan of the Waste to Energy facility

**Action:** Metro Vancouver to identify the purpose of presentations being added to future Industry Advisory Committee Agendas – for information purposes or for discussion/feedback of Committee members.

It was noted that internal discussions would ensue with the Industry Advisory Committee Co-Chairs on appropriate next steps to bring the draft 2024 Work Plan forward for the Committee's consideration and that Committee members will be presented with a draft 2024 Work Plan at the January 2024 meeting.

#### 6.1 Zero Waste Committee Updates

Paul Henderson referred to an onscreen slide and highlighted items being brought forward to the Zero Waste Committee for information or decision:

- Scaling Up Regional Reuse, Repair, and Food Recovery
- 2024 Budget and Five-Year Financial Plan
- North Surrey and Langley Recycling Depot
- Notice of Bylaw Violation and Dispute Adjudication bylaw engagement
- District Energy Waste-to-Energy Facility.

During discussion and in response to questions, comments were offered regarding:

- Suggestion to solicit the expert advice of the IAC Committee members before submitting decision items to the Zero Waste Committee
- Industry Advisory Committee Co-Chairs will be discussing how to increase member participation related to linking its work with that of the Zero Waste Committee
- View that responses to questions about the lifespan and capacity of the Vancouver Landfill are not transparent
- Confirmation that the Zero Waste Committee meetings are open to the public and livestreamed

- The Design and Operations Plan included in the Operational Certificate for the Vancouver Landfill; the remaining life of the landfill depends on the annual deposits
- Suggestion that "less is more" as it relates to the 2024 Work Plan
- Suggestion to dedicate one topic at each IAC meeting for more in-depth discussion, e.g. engage on tipping fees prior to the increases being finalized, landfill closures, plans for the current incinerator, etc.

Year expected to reach 20 million tonnes based on current quantities	Approximately end of 2030

## **NEXT STEPS**

- Focus on waste reduction
  - Updated solid waste management plan to focus on waste prevention and reduction
  - Reducing waste will mean 20 million tonnes reached post 2030
- Continue to manage residual garbage after Landfill agreements expire
  - Increased remote landfill disposal is a possible short term solution
  - Residual Waste Management Options Review to provide more information on potential options
