

#### **MEETING MINUTES**

Co-Chair Craig Hodge called the meeting to order at 1:04 p.m. and welcomed attendees to the Solid Waste and Recycling Industry Advisory Committee meeting.

Co-Chair Hodge called for additions or changes to the agenda. No additions were put forward.

#### 2. CO-CHAIR OPENING COMMENTS

Co-Chair Lori Bryan relayed housekeeping items and reminders for members in attendance, or those previously absent.

#### 3. MINUTES

#### 3.1 March 5, 2024 Meeting Minutes

Co-Chair Bryan called for additions or changes to the meeting Minutes of March 5, 2024. None were identified by Industry Advisory Committee members.

#### 4. CO-CHAIR ELECTION

#### 4.1 Voting Process

Co-Chair Hodge reviewed the election process, which involves the election of one Co-Chair based on a simple majority among the Industry Advisory Committee members present. Voting members are defined as Industry Advisory Committee members who have held membership for at least one month prior to the day of the vote. The election and nomination process was further explained, and it was noted that Lori Bryan had been offered and accepted the Co-Chair nomination at the March 5, 2024, meeting.

#### 4.2 Nominations

Co-Chair Hodge called for additional nominations for Co-Chair three times, with no nominations offered.

#### 4.3 Election

There being only one nominee Co-Chair Hodge announced that Lori Bryan was the acclaimed Co-Chair for 2024.

- Terms of Reference:
  - Goals of the Terms of Reference are not being accomplished
  - Reference should be made to Committee members' work in the work plans
  - Should define staff roles
- Working Sub-Group:
  - Proposal: One Sub-Group to focus on key items
    - Long-term Disposal Planning
    - Generator Levy
    - Capital Budget
    - Competition
  - Intention of group is to work with, and report back to, the Industry Advisory Committee
  - o Draft Terms of Reference for working sub-group has been developed
  - Currently 11 of 30 Industry Advisory Committee members have indicated interest in participating in the working sub-group
  - Consider changing the language to "Focus Group" instead of "Sub-Group"
  - o The Ministry of Environment should observe the conduct of the Committee.
    - Members were reminded that the Ministry of Environment was present at the meeting.
  - Attendance in any working sub-group meetings should not be mandatory. Members should be allowed to attend based on topic
  - Consider adding supplementary meetings to the regular committee schedule instead of convening a separate working group

#### It was MOVED and SECONDED

That the Solid Waste and Recycling Industry Advisory Committee approve the formation of a Residuals Management Working Sub-Group to focus on key topics related to: Long-term Disposal Planning, Generator Levy, Competition, Procurement, and Capital Budget.



## **REGIONAL RECYCLING AND DISPOSAL IN 2022**


Shown in metric tonnes


## **DISPOSAL BAN PROGRAM**

Tipping Fee bylaw

 The solid waste regulatory program also promotes compliance and enforcement with the Tipping Fee bylaw

Facility inspections


 Key tool used for monitoring compliance at private solid waste facilities

Permitting and enforcement officers

Promote compliance with solid waste management bylaws

## LICENSED FACILITIES

- 36 licensed facilities
  - 22 Brokering
  - 13 TS / MRFs
  - 1 Disposal Facility
- 26 facilities authorized to accept C&D waste
- Licences posted on website
- Updates in progress:
  - Re-label facilities not accepting MSW as "Inactive"
  - Update the information displayed when you click on any facility



## MUNICIPAL C&D DIVERSION REQUIREMENT

Examples

## District of North Vancouver

- Salvage requirement of 3.5 kg of reclaimed lumber/sq ft of finished floor space
- Wood salvage plan
- Refundable waste diversion deposit
- Non-refundable administrative fee

## City of Richmond

- Recycling requirement of 70% of demolition debris
- Plan for waste disposal and recycling services
- Non-refundable fee
- Refundable demolition fee
- House moving and salvage program
