### PROJECT UPDATE

## **Upcoming Work**


Metro Vancouver is replacing the Central Park Water Main to help ensure the continued delivery of high-quality drinking water well into the future. This new water main will meet growing regional demands, and is also designed to withstand major earthquakes. Central Park Water Main – Imperial Section Phase 1 extends along Imperial Street between MacPherson Avenue and Griffiths Avenue. Construction for this phase began in January 2025 and is expected to continue for the next two years.

The current work zone between Empress Avenue and Ashworth Avenue is nearly complete and will reopen once finished. Starting the week of March 17, crews will work between Sperling Avenue and Ashworth Avenue for approximately three weeks. Starting on March 28, crews will move to the next zone between Avenue and Griffiths Avenue, and along Griffiths Avenue between Imperial Street and Elwell Street for approximately three weeks.

### Traffic, Safety, and Impacts

#### Week of March 17 - Week of March 28

- Full Road Closure: Imperial Street (east of Sperling Avenue to Griffiths Avenue)
- Pedestrian Walkway Closure: Along the north side of Imperial Street between Sperling Avenue and Griffiths Avenue
- Parking Restrictions: No access or parking within the road closure area
- Temporary Detours: Please follow signage and directions from traffic control personnel. The following areas will be restricted to local traffic only:
  - Imperial Street, between Sperling Avenue and Griffiths Avenue
- Noise: Residents may hear noise from heavy machinery and increased truck traffic



#### March 28 - Late April

- Full Road Closure: Imperial Street (east of Sperling Avenue to Griffiths Avenue), and Griffiths Avenue (between Imperial Street and Elwell Street)
- Pedestrian Walkway Closure: Along the north side of Imperial Street between Sperling Avenue and Griffiths Avenue
- Parking Restrictions: No access or parking within the road closure area
- **Temporary Detours:** Please follow signage and directions from traffic control personnel. The following areas will be restricted to local traffic only:
  - Griffiths Avenue, between Burford Street and Imperial Street
  - o Imperial Street, between Sperling Avenue and Ashworth Avenue
  - Imperial Street, between Halligan Street and Griffiths Avenue
- Noise: Residents may hear noise from heavy machinery and increased truck traffic

Metro Vancouver is working with the City of Burnaby to minimize traffic disruptions in the area. Please follow detour signage and allow extra time to travel through these areas.



#### Hours of Work

Typical hours of work will be Monday to Friday between 7:00 am and 5:00 pm. All work will comply with the City of Burnaby bylaws or granted bylaw variances. There may be times when construction crews work longer hours to complete critical activities safely and efficiently. Metro Vancouver will notify the community in advance about activities outside of bylaw hours.
